

## **Public Seller Terms & Conditions 2026**

- 1) Delivery of goods to the Canterbury University Snow Sports Club Incorporated (CUSSC) shall constitute the agency where the CUSSC is the Vendor's agent to sell the goods on the terms provided. The CUSSC Agency shall be irrevocable by the vendor from the time of delivery until 3.30pm on May 3<sup>rd</sup>, 2026 (Sale Day). The CUSSC reserves the right to revoke the agency and withdraw the goods from the sale at any time prior to, or during the sale.
- 2) **The CUSSC reserves the right to refuse or accept goods for sale unconditionally.**
- 3) Upon delivery of the goods to the CUSSC, the Vendor will complete and sign a Sales record, agreeing on a price to sell the goods. The Vendor will receive a sticker to place on the goods. This will display a price, size and description of the goods along with the reference number and barcode. This number will match a second sticker that is to be affixed to these terms and conditions. This is the Vendor's receipt and must be surrendered to the CUSSC when collecting unsold goods.
- 4) The CUSSC will offer the goods for sale on the Sale Day by private treaty upon the posted terms and conditions of the sale. The CUSSC reserves the right to charge prospective purchasers an administrative (entry) fee.
- 5) **Commission on goods sold will be 20% of the sale price (GST Inclusive), with a minimum commission of \$5.**
- 6) **The minimum sale price of an individual item entering the sale is \$10. Therefore, we will not accept any item with a monetary value of less than \$10. The minimum commission will still apply.**
- 7) Payments to vendors will be held for fourteen days after the sale to enable clearance. Payment can be expected 7 days after this via a bank transfer into a nominated bank account. A copy will be sent by email to those opting for a bank transfer to the nominated email address provided upon registration.
- 8) **Unsold goods should be claimed on the Sale Day from the CUSSC on production of the Vendor's copy of the Terms and Conditions (receipt). A security docket will be issued to enable goods to pass through the security checks and removed from the sales venue. Claims are to be made between 5pm and 6pm on the Sale Day.**
- 9) Unsold goods not collected on sale day may be claimed from the CUSSC by arrangement via the provided email. These collection dates/times will be arranged based on the CUSSC's availability. Goods not collected on sale day will be held by the CUSSC at a nearby offsite location for storage and collection. It is the Vendor's responsibility to contact the CUSSC to arrange the release of their gear. Gear collected outside of the designated pickup times provided by the CUSSC, will incur a **\$10 collection fee. If the gear is not collected within 3 months of the Sale Day, the gear will become property of the CUSSC.**
- 10) All goods are left with the CUSSC at the vendor's risk until sold. The CUSSC will take reasonable care in the handling and storage of goods but is not responsible for any loss or damage except to the extent that such loss or damage is caused by its failure to take reasonable care or as otherwise required by law. Where goods recorded as unsold cannot be located at the conclusion of the sale, the CUSSC may treat those goods as sold for the purposes of accounting to the vendor, unless there is clear evidence to the contrary.
- 11) The vendor warrants that the goods delivered to the CUSSC are owned unconditionally by the vendor and are not subject to any security or charge. CUSSC holds the right to contact authorities if the goods are believed to have been obtained illegally.
- 12) Information concerning the sale by the Vendor herein may be used for statistical purposes by the CUSSC and shall remain property of that association. The Vendor authorizes that the CUSSC is to use such information but in accordance with the provisions of the Privacy Act 1993.
- 13) The CUSSC will make a reasonable effort to ensure goods presented for sale are complete, however they accept no responsibility for missing parts or fastenings.

**Commission will be charged at 20% above the \$5 minimum fee.**

**There is a minimum sale price of \$10 per item.**

**If you have opted to donate your goods you do not need to pick up.**

**Gear not picked up within 3 months of Sale Day will become property of CUSSC.**
